

Twelve Oaks Special District Board of Trustees Minutes of Monthly Meeting January 10, 2024

The Trustees of the Twelve Oaks Special District (TOSD) held their regular monthly meeting in person on Wednesday, January 10, 2024 beginning at 7:00 pm. President, Paulo Ponce presented the meeting agenda and called the meeting to order. Vice-President, Sarah Wentworth led those in attendance in the Pledge of Allegiance.

COMMITTEE REPORTS:

Maintenance:

- Stormwater ponds Rob Little, Project Manager, reported that the LED lights on the fountain have been replaced and everything is working fine

- Trevor Thompson has been instructed to continue maintaining the islands rather than refurbishing them

NEW BUSINESS:

- Storage Unit (Life Storage) monthly insurance charge increase from \$16 to \$26.52. The Board had continued discussions regarding securing an alternate storage location
- Change in auditors Julie Hirst discussed the increased auditor costs. The Board unanimously voted (6-0) to retain King & Walker to perform the 2022/23 audit.
- The Board unanimously voted (6-0) to rent a bus to transport residents to the 2/20/24 zoning commission hearing regarding the Armand Dr. & Soccer Ave. property
- Julie Hirst reported that the Hillsborough County Sheriff Deputy who resides on Sunshine Circle will begin patrolling the neighborhood as part of her daily patrol route.
- The Board unanimously vote (6-0) Nancy Hendrix and Iraida Pizarro as Trustees to the Board. Nancy Hendrix and Iraida Pizarro were sworn in as Trustees to finish out the 2024 term.
